**Explanation of Responses:**

- The sale of stock reflected in this Form 4 was effected pursuant to a Rule 10b5-1 trading plan entered into by the Reporting Person on May 17, 2024 covered by previously vested RSU shares.
- Pursuant to the Bitcoin Depot Inc. 2023 Omnibus Incentive Plan, the reporting person was granted restricted stock units ("RSUs") on April 1, 2024. Each RSU represents a contingent right to receive one share of Class A common stock upon vesting. The RSUs vest periodically as follows: 25% of the RSUs will vest on each of the first four quarterly anniversaries of the vesting commencement date. Upon vesting, the RSUs will be settled by delivery of shares of Class A common stock.
- The price reported in Column 4 is a weighted average price. The shares were sold in multiple transactions on March 3, 2025 at prices ranging from \$1.11 to \$1.142, inclusive. The reporting person undertakes to provide to the issuer, any security holder of the issuer or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the range set forth in this Form 4.
